

CASTLE HEIGHTS CRIME REPORT – May/June 2006

Home Invasion Robbery:

- Cheviot Dr & Earlmart Dr: Occurred 5/11/06 at 8:15 AM. The suspect knocked on the door, which was answered by the nanny and owner of the residence. The suspect asked for a female by name, to which the resident replied that no one by that name resided there. As the resident was about to close the door the suspect forced his way into the residence. The suspect produced a blue-steel automatic gun and proceeded to force the victims into a room. The suspect stated that he had observed the victims husband drive away, so apparently he was casing out the neighborhood. The suspect proceeded to ransack the residence and was in the residence for only a few minutes. The suspect fled the residence on foot with property. No one was injured during the incident.

The Suspect was described as male, Black, brown eyes, 6'0"-6'1", 180 lbs about 20-25 years of age, bald, wearing an earring, beige shirt, blue jeans and white shoes.

Miscellaneous Activity:

- 10300 Cheviot Dr: Occurred 6/22/06 at 9:15 PM. Suspect exited a white vehicle and began to walk towards the victim. Victim fearing for her safety, began to run, and was chased by the suspect. The victim was able to run into a nearby house for safety. The victim was not harmed. Suspect described as: male, Hispanic, 5'4"-5'5", 200 lbs, aged in his 40's. He was wearing a dark t-shirt.

Robbery:

- (Attempted) 3400 Manning Ave: Occurred 6/18/06 at 2:10 PM. Suspect approached victim from behind, pointed a knife at victim and demanded money. Victim not injured. Suspect described as: Male, Hispanic, 5'6", medium build, 20-30 years of age, wearing a black t-shirt, red shorts, and black sunglasses.
- 3300 Castle Heights Av: Occurred 6/16/06 at 1:00 AM. Suspects approached and pushed victim into apartment. Suspects then forced victim to an ATM to remove money. Suspect 1 described as: Male, White, black hair, blue eyes, 6'0", 140 lbs, 25 years of age, wearing a black sweatshirt, black shirt, blue jeans. Suspect 2 described as: Female, White, blond hair, 6'0", 260 lbs. 35-40 years of age, wearing a blue jogging suit.
- 3300 Castle Heights Av: Occurred 6/4/06 at 2:20 AM. Suspects approached victims and demanded their property. Suspect 1 described as: Male, Hispanic, brown hair, brown eyes, 5'8", 150 lbs, 18 years old. Suspect 2 described as: Male, Hispanic, brown hair, brown eyes, 5'10", 150 lbs, 20-23 years of age. Suspect 3 described as: Female, Hispanic, brown hair, brown eyes, 5'10", 175 lbs, 17-18 years of age.
- 3300 Castle Heights Av: Occurred 6/4/06 at 2:30 AM. Suspects approached the victim and grabbed victim from behind. The suspects demanded victim's purse. Victim was not injured. Suspect 1 described as: Female, Hispanic, brown hair, brown eyes, 5'4", 125 lbs, 17-18 years of age, wearing a white baseball cap, white t-shirt, blue jeans. Suspect 2 described as: Male, Hispanic, brown hair, brown eyes, 5'9"-5'10", 20-23 years of age, wearing a white t-shirt, blue jeans.

- Canfield & Kincardine: Occurred 5/12/06 at 3:30PM. Suspects approached victim and physically removed property from the victim. Bodily force used.
Car used was an '96-'98 Toyota Corolla 4 door. Teal in color.
Suspects described as: Male, Black, black hair, brown eyes, 5'10"-5'11", 18-20 years of age, wearing a black t-shirt.
- 2955 Robertson Bl (Hamilton High): Occurred 5/4/06 at 2:20PM. Suspects, who are known to the victim, used bodily force to remove property.
- 2704 Robertson Bl (Dave's Liquor): Occurred 5/4/06 at 7:00 PM. Suspects entered the store, pointed a gun at victim and demanded money. When a customer entered the store suspects fled taking only beer.
